#### ApexFlow Ltd TERMS OF SERVICE

THIS LEGAL AGREEMENT BETWEEN YOU AND ApexFlow Solution SDK ("ApexFlow ") GOVERNS YOUR USE OF THE SERVICE AND OTHER ApexFlow PRODUCTS AND GAMES (together the "Service").

Your use of the SERVICE constitutes your express acceptance without reservation of these Terms of service. Use of the SERVICE is also governed by the ApexFlow Privacy Policy and any other terms of use applicable to THE PRODUCTS (AS DEFINED HEREIN) you use within THE SERVICE, including any amendments or updates thereto.

#### PAYMENTS, TAXES, AND REFUND POLICY
